This form is for entry to the 2020 World Livestock Auctioneer Championship (WLAC) Qualifying Events. All contestants must submit a completed 2020 WLAC entry form. Required information is indicated with an (*) asterisk below. To qualify for competition at any stage of the WLAC, each entrant must complete an official WLAC entry form, be at least 18 years of age, auctioneer livestock at least once per month at a regularly scheduled livestock auction and be in good financial standing with all LMA members. Each contestant must be sponsored by and include the contact information of at least one regularly selling livestock auction (LMA membership is not required of sponsors) willing to vouch for his/her status as a livestock auctioneer. Contestants are allowed multiple sponsors, however sponsors are limited to regularly selling livestock auctions or dealer businesses. Sponsors may be contacted by LMA to verify contestant information. For complete rules and contest procedures go to www.lmaweb.com/WLAC/rules.

Contestants may enter up to two WLAC Qualifying Events during the competition year. After qualifying for the 2020 WLAC Semi-Finals, contestants are ineligible for competition in any remaining 2020 WLAC Qualifying Events.
